CALL TO ORDER:

The regular meeting of the Prattville Board of Zoning Adjustment (BZA) was called to order by Chairman Leo Jamieson at 4:09 p.m. on Tuesday, September 13, 2011.

ROLL CALL:

Present: Chairman Leo Jamieson, Vice-Chairman John Gillian, Mr. Mac Macready, Mrs. Jerry Schanep and Commander Michael Whaley. Absent: Mrs. Kitty Houser.

Staff present: Mr. Joel Duke, City Planner and Ms. Alisa Morgan, Secretary.

Chairman Jamieson stated the governing rules for the Prattville Board of Zoning Adjustment according to the *Code of Alabama, 1975* and the procedure of the meeting.

MINUTES:

Mr. Macready moved to approve the minutes of the August 9, 2011 meeting. Mr. Gillian seconded the motion. The motion to approve passed unanimously.

ADMINISTRATIVE APPEAL

Mr. Duke stated that prior to the meeting he had a conversation with Mrs. Gillespie; she decided that she and her husband was withdrawing the administrative appeal request.
