8 **WHEREAS**, an abundance of overgrown grass or weeds:

10 1. is injurious to the public health, safety and general welfare by providing a breeding
11 ground and shelter for rats, mice, snakes and mosquitoes and other vermin;
12 2. may cause the further spread of weeds;
13 3. may hide debris, such as glass or metal, that could inflict injury on a person going to
14 such property; and
15 4. may also pose a fire hazard and respiratory hazard; and

17 **WHEREAS**, §11-67-1 et Seq., of the *Code of Alabama, 1975* as amended, permits the
18 City Council of the City of Prattville to declare an abundance of overgrown grass and weeds
19 to be a public nuisance; and

37 Commissioners, is ordered to abate the abundance of overgrown grass and weeds;

39 3. the owner of said property is ordered to appear before the City Council of the City of
40 Prattville at a public hearing at 6:00 p.m. on February 19, 2019 in Prattville City Hall.
41 Notice of such hearing shall be sent by certified mail to owner of said property.
